Transnational Giving Europe (TGE) is a network which enables Old Members and friends in several European countries to now make tax-efficient gifts to University College Oxford (Registered Charity No. 1141259), via the UK Charities Aid Foundation (CAF). A 5% fee is taken by TGE on the donated amount for gifts until 50,000€. For higher gifts, 1% of the amount in excess of the 50,000€ is charged. The maximum fee is 6,500€.

Ensure that you state clearly in your correspondence with them that you would like your gift to be directed to University College Oxford. Your donation will be sent to Univ, via CAF, after approval of the gift by both partner foundations involved.
